Selection for admission to the Master's and Doctorate programs in 2025/01

1. The Coordination of the Graduate Program in Biomedical Gerontology (GERONBIO) of the School of Medicine of the Pontifical Catholic University of Rio Grande do Sul (PUCRS) hereby publishes the rules of the 01/2025 Selection Process for admission in the first academic semester of 2025/1, at the Master's and Doctorate levels, in accordance with the requirements of the Program's Regulations and the University's Statutes and General Regulations.
2. The Program, concept 7 (seven) by the Coordination of Superior Level Staff Improvement (CAPES), has 1 (one) area of concentration called Biomedical Gerontology.

The program has the following lines of research: (1) Biological Aspects of Aging, (2) Clinical and Emotional Aspects of Aging, (3) Sociocultural, Demographic and Bioethical Aspects of Aging and (4) Aging and Public Health.

3. Eligibility

All holders of undergraduate degrees, duly recognized by the Ministry of Education (MEC) or by the competent body in their country of origin, as well as undergraduate graduates, may take part in the Master's Degree Selection Process, provided that they can prove that they completed the course before enrolling in the Postgraduate Program. Likewise, all holders of undergraduate degrees, duly recognized by the MEC or by the competent body in their country of origin, who are proficient in English and who meet one of the following requirements may take part in the Doctorate Selection Process: (1) Master's degree completed in a Postgraduate Program recommended by CAPES, (2) scientific production of relevance, with at least one article published in a journal with an **impact factor ≥ 1.0** or **Qualis B1** or higher in the **interdisciplinary area of CAPES** as first author or last author.

4. Places for candidates

This selection aims to fill up to 10 vacancies at Master's level and up to 10 vacancies at Doctorate level. In addition to the ten (10) places on offer at Master's level, five (5) places will be offered to foreign candidates and five (5) places will be offered to self-declared

black, brown or indigenous candidates. Likewise, in addition to the ten (10) places on offer at PhD level, five (5) places will be offered to foreign candidates and five (5) places will be offered to self-declared black, brown or indigenous candidates.

5. Registration

Registration will take place exclusively on the Internet, via the link: <https://webapp.pucrs.br/inscricao-stricto/#/login>, from **September 1 to November 29, 2024**.

6. Documents

When registering online, the documents specified below must be uploaded:

- 6.1. Identity card or, in the case of foreigners, passport or National Foreigner Registration (RNE);
- 6.2. Individual Taxpayer Registration (CPF) (for Brazilians only);
- 6.3. **Documented Curriculum Lattes/CNPq*** (<http://lattes.cnpq.br>). If foreign candidate, *Curriculum Vitae*;

**with a copy of the supporting documents and numbered pages (fill in Annex IV for Doctorate or Annex V for Master's Degree)*

- 6.4. A double-sided copy of your Bachelor's and/or Master's degree (the latter only for PhD candidates who already have a Master's degree) or proof of the Bachelor's or Master's degree completion by the date of enrollment;

Note: Candidates who submit only an official declaration of completion of their Bachelor's or Master's degree, issued by their university of origin, will, if selected, be required to submit a copy of their Bachelor's or Master's degree diploma at their first registration. If the candidate does not submit this documentation at registration, s/he will lose the place.

- 6.5. Copy of the academic transcript of the Bachelor's and/or Master's degree (the latter only for PhD candidates who already have a Master's degree);
- 6.6. Letter of intent from Descriptive memorial for Master's degree candidates (Annex I);
- 6.7. Research Project for applicants to the Doctorate course (Annex II);
- 6.8. Candidates with disabilities or special educational needs who require specific assistance or adapted material must attach a recent report (maximum 12 months) to the documentation, issued and signed by a specialist accredited by the Regional Medical Council (CRM). The document must specify the nature, type and degree of disability, as well as the conditions recommended for carrying out the assessment activities provided for in this Notice.
- 6.9. Specific requirements for admission to the PhD course:

- 6.9.1. Have completed a Master's Degree in a Postgraduate Program recommended by CAPES **OR** relevant scientific production, with at least one article published

in a journal with an **impact factor ≥ 1.00** or **Qualis B1** or higher in the **interdisciplinary** area of CAPES as first author.

- 6.9.2. Proficiency certificate in English, at post-graduate level, in Brazilian higher education institutions, with a minimum grade of 7.0 (seven), not older than 10 (ten) years from the date of completion. This certificate is of a qualifying nature and is not compulsory for entry to the course;

7. The Selection Process

7.1. The Selection Committee

The selection committee will be made up of three (3) professors from the program defined by the coordinating committee.

7.2. Stages of the Selection Process

7.2.1. Analysis of the *Curriculum Lattes*;

7.2.2. Analysis of the Research Project (only for doctoral candidates) and memorial (for Master's candidates);

7.2.3. Individual interview.

Note: Interviews will be held via videoconference between **December 2 and 6, 2024**. Further details, specific dates and times will be emailed to candidates.

7.3. Selection Criteria

Candidates will be ranked according to the criteria specified below, with performance in each of these criteria being used in the composition of the candidate's final ranking score:

7.3.1. Evaluation of the Documented *Curriculum Lattes* (or *Curriculum Vitae*, if foreign candidate), taking into account scientific production over the last 5 (five) years with a weight of 5 (five);

7.3.2. Research Project for applicants to the Doctorate course with a weight of 4 (four);

7.3.3. Descriptive memorial for applicants to the Master's program, weight 4 (four);

7.3.4. Individual interview with a weight of 1 (one);

7.3.5. In the event of a tie in the final result, the tie-breaking criteria will be in the following order:

7.3.5.1. The candidate with the highest score in the evaluation of the *Curriculum Lattes* Documented (or *Curriculum Vitae*, if foreign candidate);

7.3.5.2. The candidate who obtains the highest score in the evaluation of the Research Project or descriptive memorial.

7.4. Final ranking

7.4.1. Only candidates who achieve a mark equal to or greater than 5.0 (five) will be considered successful.

7.4.2. Candidates will be ranked on the basis of their final grade, from highest to lowest, within the limits of the number of vacancies.

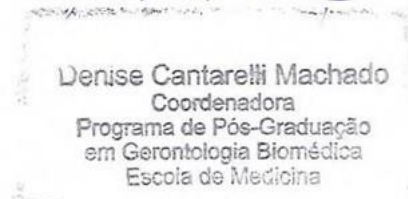
10.3. The documents of not selected candidates and selected candidates who fail to enroll in the program will be deleted from the system after the enrollment period.

Annex I: DESCRIPTIVE MEMORIAL MODEL

The *memoir* is a text in which the candidate presents a reflection on their work and/or study experiences. Based on this reflection, the candidate explains the reasons that led them to seek the Master's Degree Program in Biomedical Gerontology. Therefore, the memorial is not a research pre-project.

The text should contain two parts. In the first, the candidate must present the most relevant moments in their career of studies and work, analyzing them critically in relation to their significance for their professional and academic performance.

Based on this analysis, in the second part, the candidate must describe the theme and the central question or questions that will guide their studies and research in the Master's program. This second part must contain theoretical reflections based on literature in the field, duly referenced, and clearly reveal the candidate's interests and aims.

The full text should not exceed 4 pages (1.5 spacing, Arial or Calibri font, size 12, 2 cm margins on A4 paper).

The candidate must present a Research Project according to the following structure:

- Cover Sheet
- Table of contents
- *Resumo* (in Brazilian Portuguese)
- Abstract
- Introduction
- Literature Review
- Justification
- Objective(s)
- Methods
- Timetable



- Budget
- References*
